




Q2 I am comfortable expressing my opinion on issues in meetings of the Board







Q4 My colleagues on the Board value my opinions





Q5 The members of the Board work well together







Q7 The Board functions only as a group in leading and overseeing the operation of the District





Q8 The Board provides appropriate direction for the Chancellor and executive leadership of the District





Q9 Members of the Board adequately review material sent in advance of regular meetings





Q10 The community has confidence in the Board of Trustees





Q11 The Board is effective in receiving and investigating concerns brought to them





Q12 The Board effectively represents the interests of the District




